Discussion and review of the following policies:

We discussed policy AC and ACA – need to take out names and leave titles (Nondiscrimination and Discrimination policies)

JICK – Bullying Prevention – Pupil Safety and Violence Prevention - Bring changes using NHSBA (New Hampshire School Board Association) 7/31/2026 version to September 3, 2026 School Board meeting for members to vote to amend/approve.

JJJ – Access to Public School Programs by Non-Enrolled Resident Students – discussed and determined to be all set as is

DFA – Investment (required to review annually) – last reviewed 01/18/2018. Minor amending to be brought to September 3 School Board meeting for members to vote to amend/approve.

Erik will add Nov 20, 2025, as the adopted date for JKAA – Restraint and Seclusion

Committee needs to find an internet usage policy to review and bring to the Board.
