Description of Matters Discussed:

A. Consideration of Manifest Educational Hardship Request. The Board considered the request of Ms. Jessica Drouin to have her daughter (L) be placed at a school outside the district due to a manifest educational hardship. Ms. Drouin had made this request to the Board at their previous meeting, but no action was taken at that time. Ms. Drouin provided an additional document in support of her request. The Board discussed the request.

On a motion by Ms. Douglas and seconded by Ms. Asdot, the Board approved the request for L's placement in a school outside the district due to manifest educational hardship for

the remainder of the current school year with transportation being the responsibility of the parent by a vote of 3-1-0 (Ms. Asdot, Ms. Douglas, and Mr. Mitchell voting in the affirmative; Mr. Wolfe voting in the negative; and Mr. Gauthier abstaining).

B. Consideration of Manifest Educational Hardship Request. The Board considered the request of Ms. Jeanette Bowers to have her son (H) be placed at a school outside the district due to a manifest educational hardship. Ms. Bowers had made this request to the Board at their previous meeting, but no action was taken at that time. Ms. Bowers had provided documents in support of her request at a previous meeting. The Board discussed the request.

On a motion by Mr. Wolfe and seconded by Ms. Douglas, the Board denied the request for H's placement in a school outside the district by a vote of 4-0-1 (Ms. Asdot, Ms. Douglas, Mr. Mitchell, and Mr. Wolfe voting in the affirmative; and Mr. Gauthier abstaining).

C. Update on Student Placed at Pembroke Academy. Dr. Freeman provided the Board with information received from the administrative office at Pembroke Academy advising the district of the poor attendance record and poor academic performance of a Pittsfield student (S) who is attending Pembroke Academy due to a manifest educational hardship.
